# **ET SOP 046 Assessment Appeal Procedure**

#### 1. PURPOSE

To provide MTC Australia, operating as a Registered Training Organisation staff, students, and clients with a guide for appeals handling to ensure that the issue is addressed in a fair, timely and confidential manner.

## 2. SCOPE

This standard operating procedure applies to:

- Students
- Trainers / Assessors
- SEE Centre Managers
- VET Senior Administrators
- RTO Operations Manager
- NSW State Manager (SEE & CTA)
- Assistant SEE Program Manager
- General Manager Education and Training
- RTO Compliance Team

## 3. **DEFINITION**

Assessment Appeal:

A request by a student to reconsider a result in relation to the:

- final outcome/result
- assessment tool
- assessment procedure.

**Complaint:** 

Dissatisfaction with procedures, outcomes or the quality of services provided by MTC Australia in relation to the following processes:

- training (classes, lessons, materials)
- course and enrolment advice and any other information provided.
- assessment (Also see Assessment Appeal.)
- issues associated with results, Certificates and/or Statements of Attainment
- issues associated with personal safety, including access and equity,
   Workplace Health and Safety and bullying, harassment, or
   mistreatment by an MTC Australia staff member or other students.
- any other activity/activities associated with the delivery of training and assessment services.

### 5. PROCEDURE

Students who undertake an assessment with MTC Australia have the right to dispute an unsuccessful assessment decision under VET Quality Framework.

MTC Australia permits two attempts to successfully complete an assessment for a unit of competency.

The student should approach his/her trainer to discuss the assessment result if they disagree with the assessment outcome.

The trainer must provide the student with feedback about his/her performance in the assessment task and explain why and/or how the assessment decision was made.

If after speaking to the trainer the student is still unhappy with the assessment decision, the trainer must inform the student of the assessment appeals handling poster (Refer to APPENDIX A)

The trainer should provide the student with an <u>Assessment Appeal Form</u> to complete and submit to the VET Senior Administrators or Site/Program Manager.

A different trainer will mark the assessment.

VET Senior Administrators or Site/Program Manager:

- will conduct the final review and will advise on the decision within 10 working days.
- must provide the appellant in writing with clear and up-to-date information about the progress of the investigation and if there is going to be an anticipated delay (more than 60 days) to reach a solution.
- must record the re-assessment result and any accompanying comments on the assessment coversheet and submit all documents to the Program Manager and/or Responsible Person.

After the re-assessment, VET Senior Administrators or Site/Program Manager must inform the student of the final outcome in writing within 10 working days.

VET Senior Administrators or Site/Program Manager must provide the RTO Compliance Team with a copy of the Assessment Appeal Form and the response sent to the student. All original documents must be kept in the student's file.

If after receiving a response to the assessment appeal the student is still unhappy, VET Senior Administrators or Site/Program Manager should inform the student of their right to request a review by the RTO Compliance Manager by advising them to send their request in writing via email to RTO Compliance <a href="mailto:compliance@mtcaustralia.com.au">compliance@mtcaustralia.com.au</a>.


